Policy Statement

ThermaCote UK is committed to ensuring the health, safety, and well-being of all employees, contractors, clients, and members of the public affected by our activities. This policy outlines our dedication to meeting the requirements of PAS 2030 and all relevant health and safety legislation in the provision of internal and external wall insulation services.

This policy applies to all ThermaCote UK employees, contractors, and stakeholders involved in our operations, including planning, installation, and maintenance activities for internal and external wall insulation.

Health and Safety Objectives

- Prevent accidents and incidents by identifying, assessing, and mitigating risks associated with our operations.

Management Responsibilities

- Ensure employees and contractors are trained, competent, and equipped to perform their tasks safely.
- Monitor health and safety performance and review policies and procedures periodically for improvement.

Employee Responsibilities

- Follow all health and safety policies, procedures, and guidelines.
- · Use personal protective equipment (PPE) and tools provided by the company in the prescribed manner.
- Report hazards, near misses, and incidents immediately to their supervisor or manager.
- Participate in health and safety training and contribute to maintaining a safe workplace.

Risk Management

- Conduct pre-installation surveys to identify and address hazards, such as structural risks, working at height, or asbestos exposure.
- Implement control measures for risks associated with manual handling, use of tools and equipment, and hazardous substances.
- Develop and communicate site-specific safety plans for each project, including emergency response procedures.
- Ensure safe access to and egress from all work areas, including scaffolding and confined spaces.

Contractor and Supplier Management

- · Only engage contractors and suppliers who demonstrate compliance with relevant health and safety standards.
- · Provide contractors with site-specific safety information and monitor their adherence to company policies.
- Conduct regular checks to ensure subcontractor activities meet PAS 2030 health and safety requirements.

Training and Competence

- Provide induction training to all new employees and contractors on health and safety policies and site-specific hazards.
- Deliver ongoing training in areas such as working at height, manual handling, and control of hazardous substances.
- Maintain records of all training activities and certifications to ensure compliance and competence.

- Develop and implement emergency response procedures for fire, medical emergencies, and other potential incidents.
- Ensure all employees are trained in the use of fire extinguishers, first aid, and evacuation procedures
- Regularly inspect and maintain emergency equipment, including first aid kits, fire extinguishers, and safety alarms.

Monitoring and Continuous Improvement
